This policy applies to participants, spectators, officials, coaches, judges and staff at all Trident Gymnastics events and activities.

PHOTOGRAPHIC POLICY

Trident Gymnastics will take photographs and moving images during Trident Gymnastics classes and programs and at Trident Gymnastics events for use on the Trident Gymnastics website, social media and other publications.



If Members do NOT want their child's image to be used in any promotional material, the Member must formally advise the Club in writing via the Operations Manager.

Trident will take all reasonable steps to ensure that the member's wishes are upheld. Trident will remove any images from the public domain that a person in the image (or their guardian) wish to be removed.

Authorised Photographers

Only Trident Gymnastics authorized staff are permitted to take photographs or film. These staff will be appropriately trained and must adhere to all Trident Gymnastics policies.

Parents and Spectators

Trident Gymnastics permits parents, guardians and immediate family members to take photographs and video during public events such as displays and competitions from the spectator areas only, and of their athlete only.

GUIDELINES FOR THE USE OF IMAGES

Diversity

Trident Gymnastics will endeavour to ensure that photographs and videos published on the Trident Gymnastics website and other publications reflect the diversity of the organisation and its members.

Health and Wellbeing

Trident Gymnastics is concerned with the health and wellbeing of its members, and as such will exclude images that may be deemed offensive or unflattering.

Furthermore, Trident Gymnastics will not actively publish imagery which suggests the use of tobacco, alcohol or prohibited drugs. In selecting photographs and videos for use, Trident Gymnastics shall not intentionally expose any person to hatred, ridicule or contempt. Trident Gymnastics will not identify persons with full names in a published image unless written approval has been obtained. If requested by a member, Trident Gymnastics will endeavour to remove any images that a person in the image (or their guardian) wish to be removed from the public domain.

Ownership

Images collected by Trident Gymnastics are the property of the Association and individuals contained in such images has no ownership rights of such images. Trident Gymnastics retains the right to use members' images in publications and promotional material. No images collected by Trident Gymnastics will be sold.
